Volunteer Responsibility Policy

Nurturing the spiritual lives of children, youth and families is a cooperative ministry. Each family who has been with the church a year or more should contribute about 8 hours, which is 5-6 Sundays, of volunteer time in the Children and Youth Religious Growth & Learning Ministry. Please choose at least one of the three opportunities to be involved below.

The first option requires the most participants. It takes 49 leaders each helping out five Sundays to adequately staff the Sunday morning curriculum at Clover Lane. Please commit to scheduling an adult family member to help for **five or six Sunday sessions** over about a three month period. Continuity is important for everyone involved so leaders are asked to commit to participation over a two or three month period.

Ethical Code of Conduct for Religious Growth & Learning Leaders

Religious Growth & Learning volunteers include all persons who work with children and youth in the Unitarian Church of Harrisburg. As persons with special responsibilities for the nurturing and care of young people in this church they are expected to maintain an environment of respect and safety. This environment should enable children and youth to develop a positive sense of self and a spirit of independence and responsibility while fostering the spiritual development of individuals and the community.

All people working with children and youth are expected:

- not to engage in behavior with children or youth that constitutes verbal, emotional, or physical abuse, this includes behavior or language that is personally threatening or demeaning.
- to neither indulge in sexually harassing behavior or engage in sexual, seductive, or erotic behavior with children or youth.
- not to allow the use of tobacco, drugs or alcohol or any illegal activities among children or youth.
- not to be alone with a child or youth in a closed room without another child, youth or adult in the immediate vicinity;
- to have never been convicted of child sexual or physical abuse.
- to implement and abide by the church rules and religious growth and learning covenant.

Any violations of the ethical code of conduct must be reported immediately to the DRE or minister. Children and/or parents who are concerned about an adult or youth worker's behavior should speak with the DRE or minister immediately.

Church Rules

In order to provide a fun, safe and sacred space for people of all ages within our church, the following rules are expected to be followed. These rules are drawn from the Unitarian Universalist principles and are found in our Religious Growth and Learning Covenant.

In this church we DO:

- Listen, speak and act with respect
- Take turns and cooperate
- Participate in group activities
- Include people, especially newcomers, in our activities
- Run, skip and jump outside
- Share toys, play equipment and snacks
- Take time-outs and/or talk with someone when angry
- Ask adults for help
- Help make church a fun, safe, sacred place for everyone

In this church we do NOT:

- Disrupt our group by being noisy, distracting or uncooperative
- Cause physical harm to others
- Throw wood chips or other potentially harmful objects
- Yell or use disrespectful language
- Threaten others with our words or actions
- Stand or jump on tables or other furniture
- Damage church property, grounds or things belonging to others
- Leave the group meeting space without permission

Consequences

When the Church Rules are not followed, we can expect one or more of the following consequences to help us improve our behavior and keep church a fun, safe, sacred space for everyone.

We may be:

- given a firm, but gentle reminder of the rule to be followed.
- asked to move to a different seat, area or activity.
- given a verbal warning to stop our behavior.
- asked to talk about the behavior with a supervising adult.
- told to take a time-out of 5 to 10 minutes.
- Asked to fill out a "My behavior at church today" form, with adult help if necessary.
- dismissed from our group. If dismissed, we will meet with the DRE. Our parent(s) or responsible adult will be notified.
- asked not to attend our group until a behavior plan has been developed with parents, the DRE and appropriate teachers.
- asked to attend a meeting with the DRE and our parent(s) to discuss our behavior at church.
